## CPI Adjustment

A new Circular on CPI adjustments issued on 21 January 2020 and is available on the website ([Circular 2 of 2020](#)). There is an adjustment required of **1.3%** on applicable referable amounts **and** for Single Scheme pensions in payment the details of which are set out in Appendix 2 of the Circular.

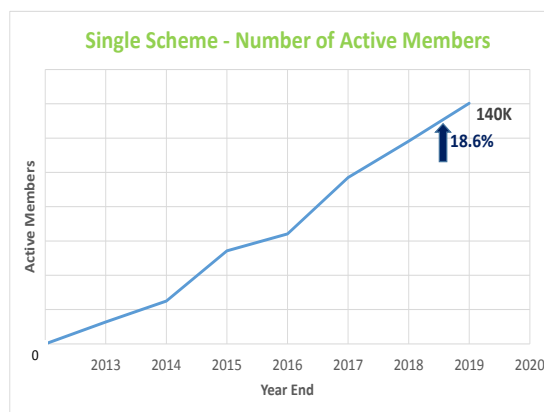

## Annual Survey for 31 December 2019

Thank you to everyone for your replies to our annual survey. The data provides the Department with important information on Scheme membership numbers and emerging trends. The information is also used to facilitate payment of fees (per member) to the Pension Authority on behalf of all Relevant Authorities. *There has been an upward trend in membership to 31 December 2019, with indications of an 18.5% increase in active member numbers since December 2018.*



## Single Scheme Databank

Onboarding to the Single Scheme Databank is progressing in waves. Onboarding of the first 3 Waves, encompassing 50 Relevant Authorities, is now significantly progressed. Wave 4 onboarding will commence in March. Thank you to those bodies who have worked to collate their data to ensure on-time uploading of files to the Databank by the relevant milestone dates.

***At this time, all bodies should be continuing to progress the preparation of Scheme Files for each year since 2013 pending a request from DPER to onboard to the Databank.***

## Training Plans

The Project Team plan to deliver more training workshops towards the end of Quarter 2 this year. It is intended to deliver re-runs of **Modules A,B&C** (*Recruitment and Onboarding, Annual Administration Activities and Leaving Employment*). Relevant Authority staff who have not attended any of these workshops before will initially have the option to register before invitations are extended to staff newly recruited to the areas of HR and Pensions Administration across all other Relevant Authorities. Invites will be issued in the coming weeks.
